Maintenance to be performed:

Annual Maintenance and Inspection

Oil filter is changed.

Oil line is flushed.

Oil burner nozzle is replaced.

The oil burner is fired & controls are safety checked.

Boiler sections or furnace heat exchanger is brushed and vacuumed.

Cad Cell is cleaned and adjusted.

Bleed Fuel Oil Lines.

Adjust Oil Pressure to OEM Specs.

The flue is inspected – a clear flue promotes proper draft.

Furnace air filter is replaced or cleaned; blower belts checked

Customer agrees to:

- Allow Sullivan Heating and Cooling to stop and start the equipment in order to perform services specified in this agreement.
- Provide reasonable means of access to the equipment, including any required removal or relocation of the equipment.

Length of Agreement:

This Agreement shall remain in effect for an initial term of (2) years and shall continue from year to year thereafter unless at least 30 days prior to the expiration date of the initial term or any extended term, either party gives the other written notice of its intention to terminate this Agreement.
